Dear President,

We are happy to confirm your qualification as per the enclosed list of qualified countries (appendix 1) and to give you the directives / invitation for The World Games 2017 which will be held in Wroclaw (POL) from 20<sup>th</sup> to 30<sup>th</sup> July 2017. We kindly ask you to carefully study this document and pay special attention to the deadlines. Thank you for your cooperation.

## **1. General Information about The World Games**

The World Games 2017 will take place from 20<sup>th</sup> July to 30<sup>th</sup> July 2017 in Wroclaw (POL). The World Games are the most important event besides the Olympic Games and take place every 4 years in the year following the summer Olympic Games. They are governed by the International World Games Association (IWGA), recognised by the SportAccord and the International Olympic Committee (IOC) who support The World Games. It is said that The World Games are the «Olympic Games» of those sports and disciplines which are not part of the programme of the Olympic Games. Similar to the Olympic Games, there are 37 sports (International Federations) in the programme of The World Games 2017.

The IWGA was founded 21<sup>st</sup> May 1980 in Seoul by 12 International Sports Federations (IF's). IWGA has now a membership of 37 IF's.

With its highest number of gymnasts, the FIG plays a very important part in The World Games. It has a total quota (participating athletes) of 326 and the following 20 events are included in the programme of The World Games 2017 Wroclaw:

Rhythmic Gymnastics (RG)	Individual: Hoop, Ball, Clubs and Ribbon.
Trampoline Gymnastics (SYN)	Men's Synchro and Women's Synchro
(TUM)	Tumbling Individual Men and Individual Women
(DMT)	Double Mini-Trampoline Individual Men and Individual Women
Acrobatic Gymnastics (ACRO)	Mixed Pairs, Men's Pairs, Women's Pairs Women's Group (3 gymnasts) and Men's Group (4 gymnasts)
Aerobic Gymnastics (AER)	Mixed Pairs, Trios, Groups (5 gymnasts) AER Dance (8 gymnasts), AER Step (8 gymnasts)

Similar to the Olympic Games, the participation is limited by a quota (number of athletes per discipline) and therefore, qualifying events and criteria are necessary.

The FIG quotas confirmed by the IWGA for The World Games 2017 – Wroclaw, have slightly changed. The details are as follows:

## 9. Entry procedures / Entry Forms / Entry Fees

### Definitive Entry

Please fill in the enclosed Definitive Entry Form (appendix 2) and return it to the FIG – Rui Vinagre, as soon as possible, but no later than **March 26, 2017** (23:59 Swiss time)



**Late entries will not be accepted and will result in the FIG automatically inviting the 1<sup>st</sup> reserve qualified country.**

### Nominative Registrations – “Long List”:

Together with the Definitive Registrations, all NFs must send to FIG ([rvinagre@fig-gymnastics.org](mailto:rvinagre@fig-gymnastics.org)) the “Long List” of all potential participants (gymnasts and officials) in TWG2017.

Please fill in the “Long List Form” – Appendix 4 – and send it to FIG until **March 26, 2017**.

With the Long List Form you must send a Photo of each one of the participants registered. The photo must be identified with **both ID (for gymnasts and judges) and Name** as in the Appendix 4; ex: **1234\_VINAGRE.jpg**

The requests for the photo are the same as for the FIG Licences. Please note that without the correct photo, participants cannot be registered in the system.

Participants not included in the Long List and without the correct photo cannot be considered for the FINAL PARTICIPATION.

### Nominative Registrations – “Final Participation”:

The final selection of participants must be send to FIG until **May 15, 2017**. These participants must have been registered in the Long List – see above).

Details will be given in due time.

### Entry fees (based on the Definitive Entry):

- RG: EUR 140 per competitor
- ACRO/AER/SYN/TUM/DMT: EUR 140 per competitor and per discipline/category

Bank details (Beneficiary name, Bank name and address, Account number, IBAN and BIC) to be used, will be stated on the FIG invoice.

The Entry Fees must be paid within 30 days after the invoice's date. The participating federation is responsible for covering all bank fees in connection with the bank transfers.

Each participating member Federation is kindly requested to state as the payment reference FIG invoice number.

Failing to do so will lead to an unidentified fund transfer and may cause your federation to appear not to have met its financial obligations.

The entry fees are not reimbursed.

## **10. Accommodation and Payments**

The WOC will pay for accommodation in twin room including full board for all qualified competitors, as follows:

- RG 18<sup>th</sup> to 23<sup>rd</sup> July = 5 nights (+1 night for participants who fly from outside of European Continent)
- AER 19<sup>th</sup> to 23<sup>rd</sup> July = 4 nights (+1 night for participants who fly from outside of European Continent)
- SYN, TUM, DMT and ACRO 22<sup>nd</sup> to 27<sup>th</sup> July = 5 nights (+1 night for participants who fly from outside of European Continent)

Accommodation for all other members of the delegation is at the charge of your federation. The costs are as follows and include accommodation in single and/or twin room, breakfast, full board, transportation, airport pick up and WOC administration fee:

Single room: EUR 180 per person / per night  
Twin room: EUR 130 per person / per night

The number of single rooms is very limited; therefore WOC and FIG cannot guarantee this type of accommodation for all requests.

The basis of *first come first served* will be applied, considering the reception date of the Entry Form (appendix 3) in the FIG.

### Accommodation Reservation Form:

Please fill in the enclosed Accommodation Reservation Form (appendix 3) and return it to the FIG Secretariat as soon as possible, but no later than **March 26, 2017**. Late Accommodation Reservation Form will not be accepted. The FIG will not be able to make any hotel reservation after **March 26, 2017**.

Bank details (Beneficiary name, Bank name and address, Account number, IBAN and BIC) to be used, will be stated on the FIG invoice.

The Accommodation costs must be paid within 30 days after the invoice's date. The participating federation is responsible for covering all bank fees in connection with the bank transfers.

Each participating member Federation is kindly requested to state as the payment reference FIG invoice number.

Failing to do so will lead to an unidentified fund transfer and may cause your federation to appear not to have met its financial obligations.

Additional nights (earlier arrival or later departure) are at the charge of your federation or if any participant would like to stay longer in Wrocław for sightseeing, the relevant costs (fixed amount covering accommodation, meals, and transportation) will be borne by the participants themselves.

- *ITO (Judges) will be accommodated either in the hotels mentioned above (with the delegations) or at a specific hotel, to be designated by WOC.*

## **11. Meals**

Each accredited person is entitled to meals.

Breakfast will be taken at the hotel.

Lunch and dinner will be taken at the catering center.

- Nutritional health factors will be taken into consideration when preparing meals
- Special meals such as vegetarian, Kosher, Muslim Halal, and other special needs will be respected and provided by WOC. Arrangements should be made during the accreditation process
- Local cuisine will also be available
- Arrangement will be made for athletes and officials whose time of competition conflicts with the hours of the catering center. Affected athletes and officials will receive a boxed or bag meal at the venue.

## **12. Transport / Flights**

All travel costs to/from Wrocław are at the charge of your federation.

WOC provides transportation service from 20<sup>th</sup> to 30<sup>th</sup> July, 2017.

Airport Shuttle for pick up and drop off service for the delegation members will be provided to and from Wrocław airport (Wrocław-Nicolas Copernic International Airport) based on the flight details given during the accreditation application process. Local transportation (shuttle buses) will be provided between the hotel and the Centennial Hall and vice-versa.

An Information Center will be set up in Wroclaw International Airport.

FIG will send to all participating NFs an “excel form” as soon as we receive the detailed information from WOC.

### **13. Accreditation Cards**

Accreditation will only be given by WOC through the FIG. FIG will, based on the information received at the time of the Definitive and Nominative Entries, request accreditation for all delegation members. Access to the various zones will be given as agreed between IWGA, FIG and WOC.

### **14. Licences**

WOC will be responsible for checking the validity of the gymnasts' Licenses. **No gymnasts will be accepted without a valid FIG License at the deadline of the Nominative Registration (Final list of participants).**

### **15. Judges**

Every delegation is obliged to send one judge for each discipline in which it participates (please refer to # 8 of this document). Judges must have a valid FIG brevet of the correspondent discipline for the Cycle 2017 – 2020. Priority must be given to the judges with category 1 and 2. Federations who don't have a judge category 1 or 2 may send a judge category 3.

Failure to enter the minimum number of judges as requested above by **March 26, 2017** will result in the FIG charging the respective member federation with Swiss Francs (CHF) 2'000.-. This amount will be used to cover the costs of an invited neutral judge. The same amount will be charged, should an announced judge not be present in due time at The World Games.

### **16. Music rights / Music forms**

The rules of the International World Games Association and the FIG require that all participating federations must clear the music rights. For all federations who have qualified competitors performing with music, it is therefore compulsory to make sure that the music used at the World Games is fully cleared with regard to commercial rights for broadcasting images and sound.

**By signing the Nominative Entry, you accept the above and confirm that you have cleared the music rights.**

The Music Form will be send to all concerned NFs in due time.

### **17. Visa**

This process is managed by the government of Wroclaw in coordination with The World Games Authorities. WOC and IWGA are working with the Polish Government in order to facilitate a smooth visa process where a visa is required.

Please check with your travel agent or embassy if a Visa is required to enter in Poland.

## **18. Insurance**

The FIG Technical Regulations foresee that all participating Federations are responsible by themselves for having the necessary insurance coverage of all participants against accidents and illness. IWGA, WOC and FIG decline any responsibility in cases of accidents or health problems during your travel and stay in Poland. It is compulsory that you check your insurance policies and make sure you are fully covered in Poland.

According to the IWGA rules and regulations **each member of delegation** has to show a proof of their health insurance cover at the Accreditation Center in order to obtain an accreditation card with full rights of participation. Without that proof of health insurance coverage, no accreditation will be delivered.

Participants without the required health insurance for the duration of The World Games 2017 in Wroclaw will be requested to pay health insurance at the time of the accreditation. Further information will be given in due time.

## **19. Doping Controls**

WOC is responsible for executing the practices of the WADA Anti-Doping Rules. Doping controls will be made during The World Games as per WADA and FIG regulations.

## **20. Publicity and Advertising**

For The World Games, the FIG Advertising and Publicity Rules apply, with the following exception: ALL advertising and publicity – size as per FIG Rules - must be approved by WOC. WOC will in principle allow all sponsors (products), which are not in conflict with a main sponsor of WOC. Federations who wish to place publicity on competition attire (incl. bags, track suits, t-shirts etc.) must make a **written request to FIG as soon as possible, but no later than June 1, 2017**. This request must include the name of the sponsor and the product, the placement and size and which competitors will wear it. FIG will then seek approval from the WOC and inform the Federation concerned about the decision.

Federations which have not presented a request until June 1, 2017, will not be allowed any publicity and advertisement on the competition attire.

## **21. Drawing of Lots**

The drawing of lots for the starting order will take place at the FIG Council meeting to be held 6 and 7 May 2017 in Baku (AZE). The exact time will be given to you in due time.

## **22. Work Plan**

The Work Plan will be distributed by the end of June 2017.
